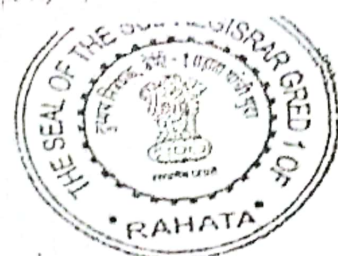
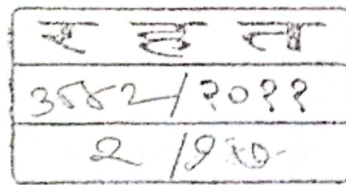


TRUST DEED

THIS TRUST DEED made at Shirdi this day 22th July, 2011 BETWEEN Shri Mahendra Ganpatrao Shelke, At. Post. H. No. 4952, A/P. Shirdi, Tal. Rahata, Dist. Ahmednagar hereinafter called "The settlor" (which expression shall unless repugnant to the context or meaning thereof be deemed to include his heirs, executors and administrators) of the one part







AND

All adults Hindu Inhabitants hereinafter called "The Trustees" (which expression shall unless repugnant to the context or meaning thereof be deemed to include the survivors or survivor of them and the Trustees or Trustees for the time being of these presents and the heirs, executors, administrators of the last surviving Trustee their his/her assigns) of the other part.

WHEREAS the settlor is possessed of a sum of Rs. 2000.00 (Rupees Two Thousands only)

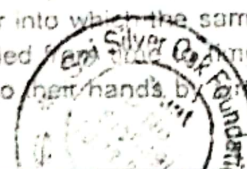
AND WHEREAS the settlor is desirous of making a educational Trust of the said sum of Rs. 2000.00 (Rupees Two Thousands only) in the manner hereinafter mentioned;

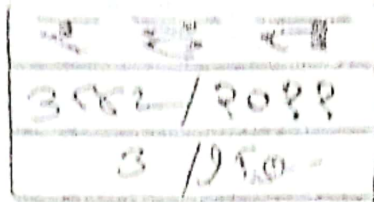
AND WHEREAS the All Trustees have agreed to become the first Trustees of these presents as testified by their being parties and executing these presents.

AND WHEREAS the said sum of Rs 2000.00 (Rupees Two Thousands only) has in anticipation of these presents being paid transferred and handed over to the Trustees prior to the execution hereof.

NOW THIS INDENTURE WITNESSETH AS FOLLOWS:

1. For effectuating the said desire and in consideration of the premises the Settlor do hereby declare that he has prior to the execution of these presents paid assigned handed over and transferred and he do hereby confirm such payment assignment handing over and transfer into the Trust the said sum of Rs. 2000.00 ( Rupees Two Thousands only) permanently and with a condition of non-withdrawal and whereas he has handed over the said amount to the board of trustee before execution of this trust deed and waived his right upon the said amount.
2. The Trustees do hereby declare that they the Trustees shall hold and stand possessed of the said sum of Rs. 2000.00 (Rupees Two Thousands only) which amounts hereinafter for brevity's sake referred to as the 'Trust Fund' (which expression shall also include any claims, properties and securities or Investments of any land whatsoever into which the same or any part thereof might be converted invested or varied from time to time or such as may be acquired by the Trustees or come to their hands by virtue of these presents





or by operations of law or otherwise howsoever in relation to these presents) upon the educational Trusts and with and subject to the powers, provisions, covenants, conditions agreements and declarations hereinafter declared and contained of and concerned and same

### 3. Name of the Trust

a) The said Trust shall be known as "Sai Silver Oak Foundation"

b) Office of the trust The postal address of the said trust would A/P Suite No. 1, Hotel Sai Mahal, Nagar-Manamd Road, (Ningaoan), Shirdi, Tal. Rahata, Dist. Ahmednagar. The office of the trust shall be change as per convenience of board of trustees. It is incumbent upon the trustees to inform the change in address to the Assistant Charity commissioner.

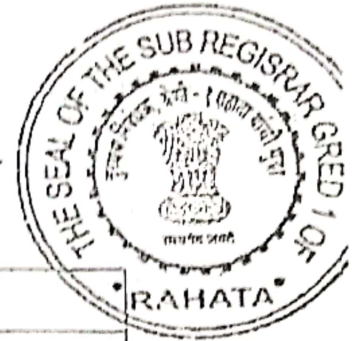

### e) Objects of the Trust

i) Providing education in rural and urban area at primary, secondary, higher secondary, collage, University level education in all faculties namely Technical, Engineering, aviation, management studies, commerce, science, Arts, Law, Agriculture, Education science, Pharmacy, Medical, Music and dance and or any other faculty in Marathi, Hindi, English or any other required language

ii) Taking Educational facilities to the door step of the society by establishing school, colleges of degree, Libraries and diploma education, spinning residential school, hostels, library, old age home, orphanage, woman houses, working woman hostels and adult education programs

iii) To endeavor in providing educational facilities to physically handicap person by running rehabilitation centers to provide training for developing self employment skills like manufacturing cane chairs, typing, computer skills in hardware.

iv) For the purpose of providing relief to the needy & senior Citizen of the society including establishment & maintenance of Old Age Home and also to run vocational centre.

v) To engage in imparting employment oriented professional education.

vi) For Development of Rural and Agriculture sector undertake projects for conservation and development of land and water.

Vii) To endeavor in setting up dispensary, Hospitals, providing Ambulance service in rural and urban area. Establishing pathology laboratories, blood banks, Eye banks, running nursing collage, Engaging in creating awareness about diseases like aids, cancer etc.

Viii) To run agriculture Science center. To engage in imparting training in agriculture science to farmers

IX) Running computer training institute including software, Hardware, Internet, Web design and all other subject in Computer Science.

X) To organize training and seminar in all faculty of education, and sports in rural and urban area.

XI) To help farmers to become self sufficient and financially sound by training then in various experiments in Farming. Establish Krishi Vidnyan Kendra, Agro School, Agro Libraries, etc for helping farmers. To provide teaching and training for competitive examinations and self employment in rural and urban area.

4. The Board Of Trustees shall hold and stand possessed of the Trust Fund upon the following Trusts

(a) To manage the Trust Fund and to collect and recover the interest dividends and other income thereof and to pay there out the expenses of managing the Trust Fund and all other outgoing, if any.

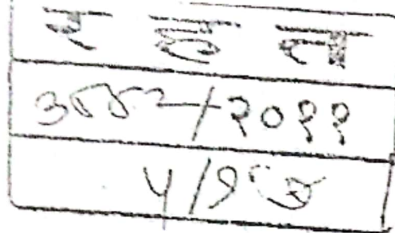
(b) To pay or utilize the balance of such interest dividends and other income of the Trust Fund (hereinafter called the 'net income') and accumulation thereof and at the desire of the Board Of Trustees the Corpus of the Trust Fund or any part of the Corpus for all or any one or more of the following purposes in India or accumulated for application to such purposes in India without any restriction as to any particular religious community caste or creed and in such shares or proportions and in such manner in all respects as the Board Of Trustees in their absolute discretion deem fit PROVIDED HOWEVER that the net income as also the Corpus shall be applied to the objects in accordance with the conditions or limitations, if any, as may from time to time be laid in the Income Tax Act, 1961 or wealth Tax Act, 1957 or any other Act governing taxation of income or wealth as will ensure or make this trust and its income eligible for exemption from taxations under the Income Tax Act, 1961 and the wealth Tax Act, 1957 and or other replacement or reenactment thereof or modification thereof under any such Act, governing taxation of income or wealth for the time being in force in India

## 5. Trust Income –

The Board Of Trustees may at any time invite and receive or without such invitation receive any voluntary contribution either from the Settlor or any







member of his family or from the Trustees or from any member of the public or any firm, company or association by way of donation legacy or otherwise for all or any of the objects and Charities mentioned above provided that they are not inconsistent with the provisions contained in these presents. The Board Of Trustees may allow any such donor to erect buildings on any land belonging to the Trustees for being used for the purposes of the Charities. Any such donation may be accepted either with or without any special conditions as may be agreed upon between the donor and the Trustees.



PROVIDED THAT such conditions are not inconsistent with the intents and purposes of these presents.

PROVIDED FURTHER that the name of foundation mentioned in clause (3) hereof shall not be altered and all such donations including any building shall be treated as forming part of the trust fund being the subject matter of these presents and be applied accordingly.

PROVIDED FURTHER that it shall always be for the Board Of Trustees in their absolute discretion to decide whatever they should invite or accept any such donations as aforesaid and they shall at all times be at liberty to refuse any donation without giving any reason for such refusal.

6. It shall be lawful for the Board Of Trustees to accumulate the income of the Trust Fund particularly at the initial stages of the operation of the foundation with a view to better enable them to utilize the Trust Fund including such accumulations for carrying on the objects of these presents.

#### 7. Appointment and Succession to trusteeship

If and so often as any of the Trustees of these presents shall die or be abroad for more than two consecutive years or become bankrupt or insolvent or desire to be discharged from or refuse or neglect or become incapable or unfit to act in the Trusts of these presents or if it shall be desired to appoint an additional Trustee or Trustees then it shall be lawful for the surviving or continuing Trustees for the time being and if there be no more surviving or continuing Trustee then for the refusing or retiring Trustee to appoint a new Trustee or new Trustees in the place of the Trustee or Trustees so dying or being abroad for more than two years or becoming bankrupt or insolvent or desiring to be discharged or refusing or neglecting or becoming incapable or unfit to act in the Trusts of these presents or to appoint an additional Trustee or Trustees as the case may be AND UPON every or any such appointment the number of Trustees may be augmented or reduced but so that the total number of Trustees shall not be more than nine or less than two and upon every appointment of a new Trustee or additional Trustee under this clause the Trust Fund shall if and so far as the nature of the funds or other circumstances shall require or admit be transferred so that the same may be vested in the Trust for the time being and every such new or additional Trustees may as well before as after the said Trust Fund shall have been so vested in him act or assist in the execution of the Trusts and powers of these presents and shall have the same powers authorities and discretions as if he or she had been originally appointed a Trustee of these presents and discretions as if he or she had been originally appointed a Trustee on his tendering his resignation of his office and on the same being accepted by the remaining Trustees of these presents.

#### 8. Framing Rules

It shall be lawful for the Board of Trustee from time to time to frame such rules and regulations for the management and administration of the foundation as they

shall think fit and to alter or vary the same from time to time and to make new rules and regulations provided that such rules and regulations shall not be inconsistent with the terms and intents of these presents. Without prejudice to the generality of the above such rules and regulations and bye-laws may include provisions with respect to the manner in which any charitable institution conducted by or under the control of the Board Of Trustees is to be used permitted to be used and the person by whom the terms and Conditions (including payment of any fees of charges on which and times at which the said charitable institutions shall be permitted to be used) as also in respect of any other object and purposes of these presents and regarding the administration and management and execution of the Trusts and powers contained in these presents as may be deemed necessary by the Board Of Trustees from time to time.



### 9. Board Meetings

(a) The Board Of Trustees shall form and regulate their own procedure relating to the meetings of the Board of Trustees and shall fix the quorum for the meetings whenever necessary. Two Trustees shall form the quorum for the meetings whenever necessary. Two Trustees shall form the quorum unless the Trustees otherwise decide.

#### (b) Requisition of Meeting -

A meeting of the Board Of Trustees shall be called least once within a period of three months at which a quorum is present shall be competent to exercise all or any of the authorities' powers and discretions by or under these presents vested with Board Of Trustees or otherwise exercisable by them. This provision shall also apply to any exercise of the powers of authority or discretion of the Trustees by an instrument in writing as mentioned in clause 10 below. The notice of the meeting shall be issued at least prior 5 days of the meeting and shall serve either by post or by hand delivery to the member of the board of trust. The date, place, timing and subject of the meeting shall be mentioned in the said notice. If the information of the meeting is to be sent by post it must be sent through postal certificate. Every trustee shall inform the latest postal address in the office of the trust.

### © Office Bearers of the Managing Committee & their Duties

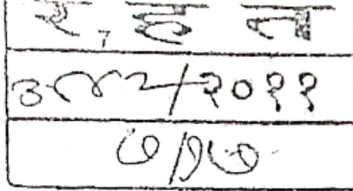
Mr. Prakash Ramrao Nikam shall be Chair Person, Every notice of the meeting shall be issued under the signatory of Chair Person and The Chair Person shall preside at all meetings. In the absence of the Chair Person at any meeting the Trustees who may be present at the meeting shall elect a Chair Person for the meeting. The Chair Person shall have the power to spend for all or any one or more of the objects of this Trust a sum not exceeding Rs. 10000.00 (Rupees Ten Thousand only) per month without consulting his co-trustees but he shall bring all such payments to the notice of all the Trustees.

#### (d) Rights and Duties of the Board of Trustees:-

- 1) To fulfill the object of the trust and do any legal work without prejudice to the interest of the trust
- 2) To read over and obtain the assert of previous board meeting.
- 3) To consider the completion of the objects and working of the trust.
- 4) To grant budget for next financial year.
- 5) To rectify of repudiate any expenditure incurred by







- 6) To accept or reject with or without condition in the name of trust any donation, gifts, assistance, and gift deed or any income by way of legal means
- 7) To file any suite in the court of law to compromise, to withdraw, to suspend any presiding for the welfare of the trust to obtain stay or in junction for the trust
- 8) To purchase, acquire, manage, to take on lease for short or long period, to develop any movable or immovable property for the management of the trust and for fulfillment of the objects of the trust.
- 9) To appoint advisory board or sub-committee for particular object or to dissolve the same but in that case the entire board of trustee shall be responsible for the act of the trust.



#### (c) Duties of Chair Person

- 1) Chair Person shall call & conduct all the meetings of board of Trustee impartially
- 2) To fulfill the object of the trust.
- 3) To Supervise and to control the functioning of the trust
- 4) To sign the documents of the trust
- 5) To give casting vote if there is equal voting

#### (e) Duties of Secretary

- 1) To present the resolution presented in the meeting of board of trustee
- 2) To appoint employees as per the requirement and to make rules regarding their service
- 3) To conduct daily working of the trust
- 4) To maintain daily, monthly and annual accounts of the trust.
- 5) To collect and deposit the contributions, donations, loans, interest or any income and to make payment of the outgoing
- 6) To prepare monthly and annual budget and to present the same to board of trustees prepare and obtain concept of the budget, profit and loss account and balance sheet
- 7) To fulfill the object of the trust and do any legal work without prejudice to the interest of the trust

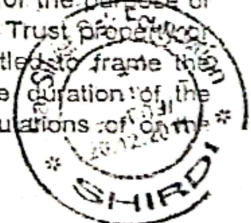
10. Every power, authority or discretion conferred upon the Board Of Trustees may be exercised or signified by some instrument in writing to be signed by all the Trustees or such of them as may be PRESENT IN SHIRDI if they are unanimous or by a Resolution of the Board Of Trustees or such of them as may be in SHIRDI and shall be present and vote at any meeting of the Trustees.

#### 11. Resolution by Majority -

In case of difference of opinion arising among the Trustees and in all matters wherein the Trustees shall have a discretionary power the vote of the majority of the Trustees for the time being voting in the matter shall prevail and be binding on the minority as well as on those Trustees who may not have voted and if the Trustees shall be equally divided in opinion the matter shall be decided according to the casting vote of the Chair Person.

#### 12. Appoint Committee Or Sub-Committee -

The Board Of Trustee shall be at liberty to form time to time one or more managing committee(s) consisting of themselves or one or more of them and such other person as they think fit to co-opt from time to time for the purpose of the management and administration of the said foundation of Trust. Any or more of them as they consider proper. They shall be entitled to frame the constitution of each such managing committee including the duration of the period for which it is to act as also to frame rules and regulations of the

management and conduct of the meetings of the managing Committee(s). The Chair Person shall be entitled to delegate to any managing committee such powers as they consider proper and desirable for running the Charity or managing the property under its management to the best advantage.

### 13. Minute Book to be kept -

The Chair Person shall keep or cause to be kept a minute book of their proceedings and proper books of account. and the accounts shall be audited by a Chartered Accountant.

### 14. Books of Accounts And Audit : -

The Trust shall keep or cause to be kept proper books of account in which all receipts and expenditure relating to the Trust shall be entered and such books shall be kept at the office of the Trust. Soon after the end of accounting year the Trust shall cause to be made and prepared all proper accounts of income and expenditure in connection with the management of Trust of the preceding year showing separately several heads of income and expenditure and such account shall be audited by a qualified auditor or auditors to be appointed from time to time by the Trust and the auditor or auditors to be appointed shall be paid his or their remuneration from Trust Fund. Audited accounts of the Trust shall be laid in the general meeting on or before 31<sup>st</sup> March of the relevant year for the information of the members of Trust and not for their approval.

#### Accounting Year -

The accounts shall be obtained every year by 31<sup>st</sup> of March

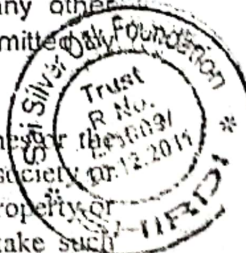
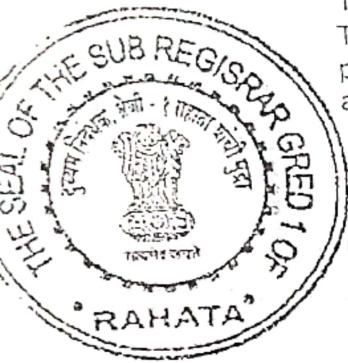
### 15. Bank accounts

The Board Of Trustee shall be entitled from time to time to open and maintain a Banking account or accounts in the names of Trust any two or more of them at such Banks or with such bankers as they may from time to time decide and may at any time pay or cause to be paid any moneys forming part of the Trust Fund or the income thereof to the credit of any such account or accounts and either by way of fixed deposit of current account or any other account. Any such account may be operated upon by Signature of Chair Person and secretary as decided in Board of trust meeting.

**16. Loan and Mortgage** - In connection with the erection, development or repairs of any immovable properties comprised in the Trust Fund or for the furtherance of any of the object of these presents or in connection with any business which the Board Of Trustees may carry on or be interested in under the provisions of these presents it shall be lawful for the Board Of Trustees on a resolution to that effect being passed by a majority of Trustees to borrow any money either on the security of the Trust property or otherwise howsoever and to enter into such agreements and arrangements with the parties from whom such moneys shall be borrowed as the Board Of Trustees in their discretion thinks fit.

**17. Investments of trust funds** - The Board Of Trustees shall be at liberty in their absolute discretion to invest the Trust Fund and any other moneys requiring investment in any of the investments as may be permitted by the Indian Income Tax Act. 1961.

**18.** The Board Of Trustees shall be entitled in their names or the names of one or more of them to become member of any co-operative society or like institution for the protection benefit and improvement of the Trust property or any property comprised therein as also enter into such contracts or take such actions and proceedings as they may think proper for the purpose of such protection benefit or improvement and to pay all fees and subscriptions and defray

#### 19. Trust Property -

It shall be lawful for the Board Of Trustees to pull down, renovate, rebuild, alter, adapt, improve add to, develop or repair any immovable properties comprised in the Trust Fund or the income thereof as they may think fit. The Board Of Trustees shall also be entitled to enter into any agreement or covenants with the owners of or persons interested in any other properties and whether restrictive or otherwise and whether for the benefit of the properties comprised in the Trust Fund or such other properties as they may in their absolute discretion think fit from time to time. The Board Of Trustees shall also have the power to insure any premises comprise in the Trust Fund against loss by fire lighting or civil commotion or other risk or losses as the Board Of Trustees may think proper from time to time but no liability shall attach on the Board Of Trustees or any of them by reason of any property remaining uninsured in any way. The Board Of Trustees shall also have the power after paying all the rates taxes and other outgoing and expenses out of rents and profits of any immovable properties to set aside out of the balance thereof from time to time such sums of money as the Board Of Trustees consider proper to meet the expenses of heavy repairs or by way of depreciation or sinking fund and to utilize the same and the income thereof for heavy repairs of for building or reinstalling immovable properties or erecting new building and in the meantime to invest the same in securities authorized by these presents. It shall also be lawful for the Board Of Trustees to permit any immovable property forming part of the Trust Fund to be held, used and enjoyed for the purpose of any scheme or other purpose of these presents. The Board Of Trustees may also allow the same or any part thereof to be occupied by any employee of any such scheme free from payment of rent or on such terms as the Board Of Trustees may think fit.

20. It shall be lawful for the Board Of Trustees at such time as they may in their absolute discretion think fit to sell by public auction or private contract or exchange or transfer or assign or grant leases or sub-lease for any part of the Trust Fund including the immovable properties comprised thereon and on such terms and conditions relating to title or otherwise in all respects as they may think proper and to buy in rescind or vary any contract for sales, exchange transfer assignments or lease or other disposition and to resell the same or enter into a fresh contract for exchange transfer assignment lease .

#### 21. Power to Employ Servants -

The Board Of Trustees may time to time appoint one or more secretaries treasurers supervisors ,clerks, teachers and other officials and employees and servants as the Board Of Trustees shall may deem expedient and fix their remuneration. The Board Of Trustees shall also have power to form and maintain provident fund, Gratuity funds pensions and other funds for any such employees and made rules and regulations regarding the payment thereof.

22 Payment of Management expenses - The Board Of Trustees or Trustee of these presents for the time being may reimburse themselves himself or herself and pay and discharge out of the Trust Funds or moneys in their hands all expenses incurred in or about the execution of the Trusts of the powers of these presents. The trustee shall out of the trust income, profit and donations, public contributions etc. in the first instance pay all the rates, taxes assessments and other out goings and in the next place all the proper charges and expenses of and incidental to the management and administration, as well as costs of current and special repairs to up keep the immovable assets, of the trust property. The management will set aside 20% of the total gross income as reserve fund for purpose of heavy repairs, renovation rebuilding of the immovable assets of property and apply the balance for the objects of the trust.

23. The Board Of Trustees shall have the power to determine in case of doubt whether any money or property shall for the purchase of the Trust be considered as capital or income and whether out of income or capital any expenses or outgoing shall or ought to be paid or borne and any and every such determination shall be binding and conclusive PROVIDED that nothing therein contained shall be deemed to authorize the Board Of Trustees to spend the income or corpus of the Trust Fund for any purpose not authorized by these presents.

24. The Board Of Trustees for the time being of these presents shall be respectively chargeable only for such Trust Funds and incomes including moneys stocks funds shares and securities as they shall respectively actually receive not withstanding their respectively signing any receipt for the sake of conformity and shall be answerable and accountable only for their own acts, receipts neglects or defaults and not for those of terms nor for any banker broker auctioneer or agent or any other person with whom or into whose hands any trust fund or trust income may be deposited or come nor for lending on any security with less than a marketable title not for the insufficiency or deficiency of any stocks funds shares or securities nor for any other loss unless the same shall happen through their own willful default or dishonesty respectively and in particular not Board Of Trustee shall be bounds to take any steps or proceedings against a Co-Trustee for any breach of Trust Committed by such Co-Trustee.

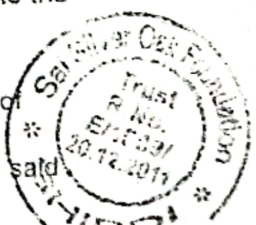
25. If any Trustee of these presents shall be lawyer or a person engaged in any other profession or business he or him, firm shall be entitled to charge for his or their professional services including all profits costs and charges in spite of the fact that he shall be Trustee of these presents whether such charges are in the ordinary course of his profession or not and although they may not be of a nature requiring the employment of a solicitor or other professional person. If any Trustee of these presents shall be broker or sub-broker he or his firm shall be entitled to charge for is or their service including any brokerage payable to him or them

26. Custody of documents - The title deeds of the immovable properties of the Trust shall be kept the Trustees in the safe at the trust premises or at the safe deposit vault of reputed bank.

27. Custody of article of value -

The board of trustees shall make arrangements for the safe custody of all articles of value, which are not in daily used but are used on special occasions the board of trustees shall maintain a list of such articles of value with all additions and substitutions from time to time. The articles or the stock of articles of value will physically checked and verified at the end of financial year.

28. Transfer of Trust Fund It shall be lawful for the Board Of Trustees at any time if they so desire to transfer and hand over the Trust Fund to the Trust of any other institution which may take upon itself the duties of administering and managing the Trusts of these presents to be used by the said Trustees or such other institute or institution upon the objects and with and with and subject to the powers, provisions agreements and declarations as those appearing and contained in these presents subject to such modification (including the modifications of the power of appointment of New Trustees or of the class of beneficiaries) as may be necessary due to the said Trustees of such other institution becoming or agreeing to become the Trustees or Trustee of the said Trust Fund.



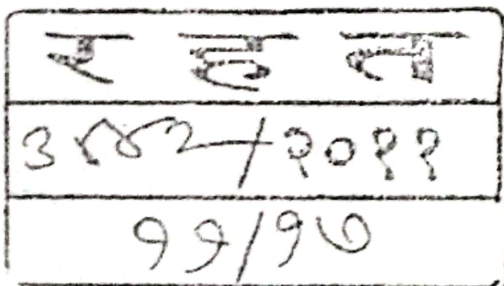


29. It shall be lawful for the Board Of Trustees to settle all accounts and to compromise compound abandon or refer to arbitration any action, proceeding or dispute claim demand or thing relating to these presents and to do all other things proper for such purpose without being responsible for any loss occasioned hereby.
